Five USCT Veterans Honored in Joint Ceremony Grave Dedication

On Sunday, 18 August, Brothers of Robert Finch Camp No. 14 partnered with Brothers of Alexander French Camp No. 28 and participated with the Old Settler's Reunion (OSRW) at Morgan West Wheatland Cemetery in Mecosta to honor five Union Veterans that received new VA headstones. The five Veterans belonged to various USCT regiments during the Civil War. Many of the settlers of the area arrived from SE Ohio, as well as from the Underground Railroad via Canada.

The Veterans honored with new headstones and the ceremony includes: Michael Norman (102nd USCT), Robert Scott (Co. F, 102nd USCT), Amos Robinson (Co. G, 29th USCT), Lewis Gross (Co. E, 16th USCT), and an Unknown Veteran.

In addition to Camp No. 14, Camp No. 28, OSRW, and various representatives of the community and descendants of these noble men – the ceremony saw Bugles Across America Bugler Thelma Paul perform Taps, and the Honor Guard of the VFW Post in Mecosta serve as the honor guard of the grave dedication. It was a wonderful event showing united teamwork between Camps and the community to honor five our Nation's defenders.



As we the men of Camp #14 look forward to a new year, it is my hope that we will be seeking out ways that we might educate those around us and bring honor to those who through their actions deserve recognition.

Northern Michigan Military Installations - Past & Present



Coast Guard Air Station Traverse City

United States Coast Guard, 9th District Traverse City, Grand Traverse County, Michigan Commissioned in 1946

Looking to the skies around Northern Michigan and especially the greater Grand Traverse region one may see and hear the white and orange MH-6oT Jayhawk helicopters of the United States Coast Guard. Those helicopters and their crews and maintainers train and stand ready at a moments notice to save those in trouble. Traverse City is honored to be named an official "Coast Guard City" by Congress and home to Coast Guard Air Station Traverse City.

CGAS Traverse City was founded in 1946 when the US Navy turned over the keys to the station to the Coast Guard. Prior to 1946, it was known as Naval Air Station Traverse City (NAS Traverse City will be covered in a future issue of The Sharpshooter).

Currently, the Air Station is situated at Cherry Capitol Airport on the east side of Traverse City. The station's physical plant consists of a spacious hangar; facilities engineering building; supply offices and warehouse; a small Coast Guard Exchange; a medical clinic; an ID card office and Smith Hall, which houses a galley, lounges, sleeping areas for 24-hour duty crews, and a new Education Center. There are also several athletic fields, two tennis courts, and a small picnic area and playground.

Lawler's remains were returned to US possession in July 2018 after the summit between the US and North Korea. It was determined that he was killed in action near the vicinity of Unsan in the Democratic People's Republic of Korea. Guard Milk, MVAO Murphy, PDC Aurand and PDC Davis represented Camp No. 14 at the event. Corporal Lawler was interred at Oakwood Cemetery.


GAR Merchandise in 1887

Sons of Veterans Unknown Medal



In the recent past, an unknown Sons of Veterans medal/badge came up for auction online. Reviewing the pictures of the badge, it was difficult to determine what the medal/badge might be worn for, and was thought to be possibly be a "Chaplain's badge". The reason for this possibility was that the reverse of the drop had the Lord's Prayer embossed on it, and said drop was in an ornate cross pattern.

The Sharpshooter Editor decided to determine once and for all what this badge might represent, thus he contacted SUVCW National Historial Bob Wolz, PDC. Brother Wolz is an expert in GAR and Allied Orders insignia and memorabilia.

PDC Wolz responded that the badge/medal is not a "Chaplain's badge", but was issued as a stock Department Encampment badge. The ribbon would have been different with the Encampment details printed on it. It was also sold as a souvenir badge for at least one National Encampment.

Many thanks to National Historian Wolz in answering this medal/badge mystery.

CGAS Traverse City cont'd.

HISTORY - Originally established as a one plane detachment to provide Search and Rescue service to the Great Lakes, Coast Guard Air Station Traverse City was commissioned in 1946. Over the years, the air station ahs grown from its original small complement to its present staff size of 17 officers and 110 enlisted personnel. In 1980, the air station increased its building space when a new maintenance and administrative hangar was completed, providing over 50,000 square feet of work space. Along with changes in size, the air station has experienced changes in the types of aircraft assigned over the years. The Consolidated PBY-5A "Catalina" gave way to the Grumman HU-16 "Albatross" seaplane and, eventually, the Dassault HU-25 "Falcon" jet. Likewise, the Sikorsky HO4S/3G (or H-19 "Chickasaw") helicopter gave way to the Sikorsky HH-52 "Seaguard" helicopter.

In 1961, air station H-19 helicopters assisted in the evacuation of the crew of the Francisco Morazán, an operation that lasted four days in continuous gale

conditions. Crews also rescued 25 survivors of the collision between the Cedarville and the Topdalsford in 1965, and 19 survivors from the fire aboard the Canadian freighter Cartiercliffe Hall in 1979.

Proving their versatility, air station personnel have participated in a variety of other operations. In 1986, a premature boy was delivered aboard an HU-25A during an air evacuation from Alpena to Traverse City, MI. Another Falcon aircraft reported to Cape Canaveral to assist in the recovery search for space shuttle Challenger.

Later in 1986, the rescue capabilities of the "Seaguard" helicopter and the patrol capabilities of the "Falcon" jet were combined in the Sikorsky HH-3F "Pelican" helicopter. At that time, Traverse City became a helicopter-only unit operating three HH-3F helicopters.

In July 1987, a sudden storm produced winds nearing 100 mph resulting in 32 SAR cases. Following another violent storm in September 1988, nine distress calls were received within two minutes. Rescue efforts resulted in saving two persons clinging to a capsized sailboat in Lake Michigan. In November of the same year, an HH-3F flying at night successfully located a downed aircraft near Marquette, MI in thick, fog covered forest. All six persons aboard the plane survived the ordeal. Three HH-3Fs were deployed on two separate occasions to respond to flooding reports in the fall of 1986, providing media and logistical support. Support was also provided following a major oil spill in the Monongahela River in Pennsylvania in 1988.

With the modernization of the aircraft fleet, three HH-60J "Jayhawk" helicopters were brought in to replace the aging Pelicans in September 1991.

The Great Flood of 1993 required the air station to play a critical and valuable role with flood relief efforts. The station provided one HH-60J Jayhawk helicopter and crew to the flood area for a continuous 60-day period.

In the spring of 1995, five HH-65A "Dolphin" helicopters replaced the three Jayhawks, which were transferred to Air Station Astoria, OR. In November of 2002, the HH-65 "A models" were upgraded to "B models" with the introduction of the Control Display Unit and other avionics components.

Since 1995, Air Station Traverse City has controlled and manned Air Facilities throughout southern Lake Michigan. On April 1, 1995, Air Station Chicago transitioned to Air Facility Glenview and fell under operational control of Air Station Traverse City. However, its colors were retired soon after on November 15, 1996, and the facility ceased operations. On April 1, 1997, Air Facility Muskegon was established and was manned with one HH-65A from Traverse City. But, on May 25, 2000, Air Facility Waukegan was established and Air Station Traverse City slowly transferred operations there. On September 30, 2001, Air Station Traverse City completely transferred Air Facility Muskegon to Air Station Detroit and took control of Air Facility Waukegan. This is still the operational situation today, with both Air Facilities operating from Memorial Day to Labor Day.

The MH-65 "Dolphin" Short Range Recovery helicopters were upgraded to the current "D model" with an advanced flight navigation system common to Department of Defense helicopters. The first production MH-65D was completed on January 20, 2011 and was fitted with a Honeywell HG7502 radar altimeter, two Honeywell H-764G embedded GPS/inertial navigation systems (EGIs), and two control display units (CDU-7000D) from Rockwell Collins

Presently, the air station maintains three MH-60T "Jayhawk" Medium Range Recovery helicopters, which replaced the four MH-65D "Dolphin" helicopters during the summer of 2017. The MH-60T provides a longer range and a larger cabin for executing complex Search and Rescue cases over a massive, often remote, eight-state area. In addition, the Jayhawk also boasts anti-ice/de-ice capability to better assist the citizens of the Great Lakes during harsh northern winters.

E.P. Case, Union Veteran Honored

Manistee resident Edward Payson Case was honored in a ceremony on o4 August 2019 held by Brother Keith Graham. E.P. Case originally was from Benzonia, and GAR Post 372 of the same location was named after Mr. Case. According to famed Benzonia native and Pulitzer Prize author Bruce Catton, "He must have been quite a man; he had enlisted in 1864, in the artillery, and his unit had been sent to Cumberland Gap on garrison duty and had finished out the war there never getting into combat. Almost to a man, our G.A.R. members had been in violent action during the war, and they never would have named the local post after a noncombat soldier if he had not been an impressive sort of person."

Brother Graham, who also is the Commander of the Manistee County United Veterans Council and a member of the UVC Ritual Squad was asked by a descendant of Mr. Case from Benzonia to honor him at his gravesite in Oak Grove Cemetery in Manistee. When the UVC Ritual Squad was unavailable due to a conflict, Brother Graham on behalf of and representing Robert Finch Camp No. 14 placed a US Flag at Edward P. Case's grave where a GAR flag holder was recently placed and gave a brief ceremony to honor him with Mr. Case's family attending. E.P. Case belonged to Company M, 1st Michigan Light Artillery.
