Otsego County's Qua Receives Headstone and Last Veteran Buried Marker





Saturday, 19 June 2021 saw Robert Finch Camp No. 14 provide grave dedication and Last Union Veteran Buried in Otsego County services for Samuel E. Qua, a former community leader in the Gaylord area.

Attendees included members of the Qua Family along with the Gaylord VFW Post 1518 and VFW Auxiliary, Michigan Army National Guard from Camp Grayling, and community members. TV₉&10 sent a reporting team to cover the event.

Comrade Qua received a new headstone, as well as a "Last Veteran Buried in the County" bronze flag marker. Both were unveiled during the combined services.

New Headstone for Beeman & Benzie County Last Veteran Buried Honors

On 10 July 2021, Camp No. 14, Auxiliary No. 9, the Beeman Family, and community members came together to honor Charles Beeman, the Last Union Veteran Buried in Benzie County. Mr. Beeman was a long-time resident of Empire in bordering Leelanau County, but was the final Union Veteran Buried in nearby Benzie County in Almira Township's Greenbriar Cemetery.

with a family reunion planned that day in the area. A very special relic was placed at the gravesite by the Beeman Family, which provided the folded US flag in its case used at Charles Beeman's funeral. In addition to receiving a "Last Veteran Buried" bronze flag marker, Mr. Beeman also had a grave dedication memorial service provided as he received a new headstone very recently.


Chaplain's Call



Between 2019 and 2021 Air Station Traverse City unwaveringly prosecuted 316 Search and Rescue cases, saving or assisting 177 lives. 
Brother Neal is deeply missed by Camp 14 for his energy and wisdom, friendship and loyalty, and for his undying love of the Order.

Ancestor Spotlight

Sergeant John H. Logue

 2^{nd} Pennsylvania Infantry, 126^{th} Pennsylvania Infantry, and 21^{st} Pennsylvania Cavalry (182^{nd} Regiment) Comrade of Corporal Rihl GAR Post No. 438 of Greenville, Pennsylvania



On August 2, 1862 he enlisted as the 2nd Sergeant in Company K, 126th Pennsylvania Infantry, a newly formed Nine Months Regiment. Company K was recruited almost entirely from amongst the young men of Greencastle.

The Regiment arrived at the battlefield of Antietam on the evening of the last full day of fighting, from Antietam the regiment marched south into Virginia. During the Battle of Fredericksburg, on December 13, 1862, John was wounded in the last assault on Marye's Heights. He spent nearly four months in the General Hospital, at Washington, D.C. He returned to the 126th Regiment in time to participate in the Chancellorsville battle in early May of 1863. This was the last action for the 126th. It returned to Harrisburg, PA, where the Regiment was mustered out on May 20, 1863. John and many of the veterans of Company K returned home to Greencastle.

In late June of 1863 Greencastle was on the line of march of General Robert E. Lee's Confederate Army in it's invasion of Pennsylvania. What John and his fellow Greencastle veterans did while the Confederate Cavalry foraged through the town is not known, but John's father, Archibald Logue received post War compensation for horses, harness, wagons and feed taken by the Rebels, lead by the notorious Rebel partisan, Major Harry Gilmore, 2nd Maryland Cavalry (Confederate). In an odd twist, Archibald Logue named his last child and John's youngest brother, born in late 1863, Harry Gilmore Logue.

Since he had completed his service with the 126th PA Infantry, John missed the Gettysburg battle which took place not many miles from Greencastle. There is ample record of Franklin County men and Union veterans harassing and ambushing the Confederate Army on both it's march and retreat. John was fit and fresh from the battlefields of Fredericksburg and Chancellorsville. There is good reason to believe that he may have been among these quickly formed local militias.

After remaining home for several months following the Gettysburg battle, possibly still recovering from the effects of the wound suffered at Fredericksburg, John enlisted as a Sergeant/Bugler in the 21st PA Cavalry Regiment. The original 21st PA Cavalry (182nd) Regiment had mustered for six months in June of 1863. A locally formed, Company B, of the Regiment had seen limited action at Gettysburg. The first soldier killed in the Gettysburg Battle was a scout from this Co. B of the 21st PA Cavalry.

Upon completing it's six months service, the regiment was reformed as the 21st Cavalry (182nd) PA Regiment, for three years service. On February 2, 1864, Greencastle provided, yet again, a Company K, recruited mostly from Greencastle veterans of Company K of the old 126th PA Infantry and Greencastle veterans of the six month 21st PA Cavalry Regiment.

The 21st PA Cavalry served first dismounted, participating as infantry in the battles of Cold Harbor and Petersburg. The regiment was remounted in early October of 1864 and saw hard fighting in the cavalry campaigns leading to the War's end in April of 1865. The regiment was present at Appomattox Courthouse for the surrender of Lee's Army, but was immediately sent south to support Union General Sherman's pursuit of the remnants of Confederate General Joe Johnson's Army. The regiment returned to Lynchburg, VA where it was mustered out on July 8, 1865. The long War had finally ended for John and the young men of Greencastle, PA.

John returned home and stayed on in Greencastle for a number of years, raising his young family. He and his wife Susan had four children, one of which was my great grandmother, Theressa E. Logue. He found local employment with the Cumberland Valley Railroad (Later the Pennsylvania Railroad). The mainline railroad tracks ran through the center of town on Carlisle St. the station and depot fronted directly onto

the street. The railroad was a large presence here and offered steady employment to War veterans. It also brought other businesses and industry to a thriving Greencastle.

John was an early member of the Grand Army of the Republic (GAR), Corporal Rihl Post, No 438 in Greencastle. Most of its members were Greencastle men who had served in locally raised Companies of the 2nd Pennsylvania Infantry, the 126th PA Infantry and the 21st PA Cavalry Regiments. Corporal Rihl was a member of Captain Ulrich Dalgran's Co C, 1st NY Cavalry, attempting to locate the exact line of Lee's march into Pennsylvania. Corporal Rihl was shot down by Confederate cavalry in Greencastle, on June 22, 1863. He was the first battle casualty of the War on Pennsylvania soil, and the first casualty, north of the Mason-Dixon Line.

Sometime later John moved his family to Pittsburgh, PA, where he continued to work for the railroad until his death in 1899, at age 57, from complications of influenza. He is buried at the Homewood Cemetery in Pittsburgh where his granite marker still stands today. His wife Susan J Logue passed away in 1917 and rests beside him.

Sergeant Logue's dates of service are as follows:

2nd Pennsylvania Infantry Regiment: April 18, 1861 to July, 26, 1861 126th Pennsylvania Infantry Regiment: August 2, 1862 to May 20,1863 21st Pennsylvania Cavalry Regiment (182nd Regiment): February 2, 1864 to July 8, 1865


