
We can improve our low voter turnout in our beloved country by making it possible for everyone to get a valid ID and to

James Gear - Manistee Co. Last Union Vet cont'd.

died in Arcadia Township, Manistee County, Michigan on 23 March 1934 at the age of 88. He enlisted as a Private in Company D, 35th Wisconsin Infantry on 15 January 1864, mustering in at Camp Washburn, Milwaukee, Wisconsin on 27 February 1864, serving 2 years and 16 days where he mustered out at Brownsville, Texas on 15 March 1866. This unit was involved in the following activities & engagements during his enlistment:

The regiment was ordered to Alexandria, Louisiana, April 18, promptly moved to New Orleans, and then traveled to Port Hudson, Louisiana, where it arrived on May 7. It served at Port Hudson until June 1864 and then moved through Arkansas, and Alabama. It participated in the campaign against Mobile and its defenses, the siege of Spanish Fort, and the capture of Fort Blakely, Alabama. Moved in June 1865 to Texas for duty until mustering out in March 1866.

Ancestor Spotlight

Corporal Jacob Aurand

Company H, 9th Michigan Cavalry Marathon Township, Lapeer County, Michigan

Not all casualties of war occurred on the battlefield. Some health issues appeared a number of years after the Civil War ended.

Jacob Anthony Aurand was a healthy 19 year old country boy, when he enlisted in the Ninth Michigan Cavalry at Marathon Township, Lapeer County, Michigan on December 15, 1862. The photograph of him in uniform (at left) is believed, to have been taken in May of 1863, when he was promoted to Corporal.

In January of 1864 during the East Tennessee Campaign the weather had turned severe. Resulting from a lack of winter clothing, tents and scarcity of rations Jacob A. Aurand became sick. In May of 1864 the Regiment returned to Nicholasville, Kentucky to be remounted. Aurand was given a 30 day leave to return home and recover.

Returning he joined the Regiment for the "Atlanta Campaign" then the "March to the Sea." After the capture of Savannah then began the Campaign in the Carolinas."

Jacob was captured at Monroe's Crossroads, North Carolina, March 10. 1865. Paroled in Virginia and sent to Camp Chase, Ohio, for discharge June 12, 1865.

In November 1865 he married Elizabeth Freeman. The photograph of the two of them is believed to be taken when they married. Take notice of his significant aging after 2 ½ years in the service.

In Pension papers, Elizabeth states that he had a cough when they met and married. His cough became progressively worse. This coughing caused severe pain in his chest. Corporal Aurand ailment was finally diagnosed as consumption.

The consumption resulted in his inability to work during the last year of his life. Corporal Jacob Aurand died on December 21, 1875 having just turned 33 years of age on November 8, 1875.

The photograph of Jacob, Elizabeth and family is the last known photo of him, taken about 6 weeks before he passed away. The little guy sitting on his knee is my grandfather Cornelius Aurand. Some of my earliest memories are sitting on that "Real Son's" knee the same way.

Duane Dewey - Korean War Medal of Honor Winner Passes Away

On 11 October 2021, the nation lost one of its true heroes and a very fine gentleman of the highest order. Corporal Duane Dewey was a patriot and a consummate supporter of Veterans and the country he loved as anyone can attest to after meeting him. This Editor had the high honor of meeting Mr. Dewey a couple of times and being able to speak with him every time. He was always graciously willing to meet with the public and share his story.

Mr. Dewey was awarded the Medal of Honor on 12 March 1953 by President Eisenhower after his meritorious actions at Panmunjom, Korea on 16 April 1952. Corporal Dewey was serving with Easy Company, 2nd Battalion, 5th Marine Regiment, 1st Marine Division while engaged in heavy combat with Chinese forces that greatly outnumbered the 80 men fighting with him. 66 of the 80 men were either wounded or killed.

During the fevered battle, Corporal Dewey was badly wounded by an enemy grenade, as well as receiving a bullet lodged in his stomach. While his Navy Corpsman was attending to the badly wounded Marine, another enemy grenade landed where he laid.

A Camp 20 Brother's Excellent Find

PDC Bill Brennan of General Benjamin Pritchard Camp No. 20 had a wonderful find during one of his travels. His newest find was an "In Memoriam" ribbon from the E.P. Case GAR Post No. 372 in Benzonia. The reader may remember that famed author Bruce Catton grew up listening to the stories of the Union Veterans of the E.P. Case GAR Post. PDC Brennan was very generous in providing pictures for "by Sharpshoter of the E.P. Case ribbon, as well as several other GAR mourning ribbons from his collection. The Zach Chandler GAR Post No. 35 ribbon in South Haven is from the GAR Post that PDC Brennan's Great Grandfather Henry P. Gillespie was a Comrade. Many thanks to PDC Brennan for providing these wonderful pictures!





Army Major Visits Local CW Veterans & Ancestors

Major Tim Petoskey, a brigade intelligence officer for the 654th Regional Support Group, reflects on his experiences being in the U.S. Army Reserve as a member of the Odawa Tribe.

Acknowledging a lost soldier from 1st Michigan Sharpshooter, Corporal Simon Sanequaby, Lincoln's Company K. He is buried in a long forgotten Indian Cemetery, unmarked behind us. IS SANEQUABY TIM'S ANCESTOR? DID TIM HAVE SEVERAL CW ARMY VET ANCESTORS THERE???

On September 22 2021 Major Petoskey and Scott met for the first time and placed an original GAR flag holder in memory of Simon Sanequaby. A traditional blessing, prayer, and cleansing in Anishinaabemowin.

Major Petoskey of Seattle is a direct relative of Igantius Petoskey, and the name sake of the City. It should be noted that he brought his uniform from Seattle to place the flag holder for a fellow Army Veteran from years gone by. Major Petoskey is the descendant of Joseph Waukazoo who served in Co. H of the 16th Michigan Infantry and Co.K, of the 1st Michigan Sharpshooters.

Duane Dewey - Medal of Honor Winner Passes Away, cont'd.



Corporal Dewey pulled the grenade under his hip and covered it, telling the men around him that he had it in his hip pocket and to take cover. The grenade went off, and miraculously Dewey survived, saving harm and/or death from those around him.

Corporal Dewey was evacuated by helicopter to a M.A.S.H. field hospital, and then on to a hospital ship before he returned to the United States, receiving the Purple Heart, and later the Medal of Honor. After the Marines, Duane and his wife of 68 years, Bertha settled in South Haven before retiring to northern Lake County (and winters in Florida). He was a fixture within many NW Michigan communities, always supporting Veteran and patriotic causes. Duane E. Dewey AMVETS Post 1988 in Baldwin is named after him.

The Sisters of Frances Finch No. 9 conducted services for the 4 ladies of the GAR Plot 241 in Oakwood Cemetery in Traverse City. Chaplain Lorraine Aurand led the services with AP Dorothy Rongey, PAP, Sister Valerie Jones, and Sister Kelly Smith assisting. Sister Rongey also read a poem during the headstone dedication services for 3 Union Veterans. Council Debra Downey and Secretary-Treasurer Lisa Smith, PAP were dressed in mourning.

Camp 14 performed simultaneous grave dedication ceremonies for William Bond, Robert Bell, and Sergeant Charles Mann. Comrades Bond and Bell were interred within the GAR Plot 241, while Sergeant Mann was buried a short distance away from Plot 241.

Upon completion of the grave dedication ceremonies, Commander Davis led the Camp in honoring Joshua Moe, Co. A, 4th Michigan Cavalry as the Last Union Veteran Buried in Grand Traverse County. 3 volleys were fired by the Camp Honor Guard and Taps was played by Thelma Paul of Bugles Across America.

Mr. Moe was mustered in as a Private in Company A of the 4th Michigan Cavalry. His service with the 4th Michigan Cavalry included:

Early in February 1864, the Regiment set out on a scouting mission in Tennessee, to gain information and hinder the Confederates. During this scout the Regiment marched over 250 miles in much privation, due to the rainy cold weather, but returned with 145 prisoners, including 2 Colonels and 14 other commissioned officers.

The Regiment remained in the Tennessee area, continually scouting and skirmishing with the rebels, until April 1864, when 800 men strong and well equipped, now armed with the Spencer repeating carbine, they left Nashville, marching to Columbia, where they became part of the 2nd. Cavalry Division. They then moved over the Cumberland Mountains to Stevenson, then Bridgeport, crossed the Tennessee River, to Shell Mound, crossed Raccoon Ridge, Lookout Valley, Lookout Mountain, Pigeon Mountain to Lafayette, then across Taylor's Ridge to Vilanon, GA. They then participated in all of the movements of the army, in the March to Atlanta. When the Regiment reached Atlanta, in August, its men and mounts had been worked to the limits of endurance.

On 12 January 1865, they again moved out, to conduct operations in the Alabama and Georgia areas. On 7 May 1865, the Regiment was ordered to proceed, as quickly as possible, to Spaulding, GA, for the purpose of preventing the escape of Jefferson Davis, who was then supposed to be making his way to the coast, and if the Regiment got on his track to follow him wherever he went, then to capture, or kill him without fail.

The camp in which Davis and his family were found was surrounded by a thick pine forest, close to a small swamp. In the camp were standing three wall tents, in line, parallel with the road, facing the opposite direction, while the narrow space between the tents, was occupied by several horses, without equipment. In this closure of tents, reposing all unconscious of the impending danger, lay Davis and his family, together with his military staff. Nearby was the rest of the camp, which appeared to be troops, with army wagons, ambulances, horses and cavalry equipment. The 4th Cavalry charged into the camp just at early dawn, completely surprising them, then making the arrest. A few Michigan men then guarded the

The Fourth Cavalry gained a national reputation, with world wide notoriety, by the capture of Davis. It was an accomplishment of an eminently special and important duty, for the nation, so distinctive and definite in its character, as to render a like service impossible, giving it a place in the history of the war, without parallel.

The Regiment returned to Nashville, and on 1 July 1865, they were mustered out of service and paid off. Returning to Michigan, they arrived at Detroit, where they were disbanded on 10 July 1865. Special thanks to GRO Sawyer for the biography.

New Challenge Coins Available



At the 11 September 2021 meeting, PDC David Smith presented those in attendance with new Camp 14 challenge coins. The coins are made in the USA, and are higher end thick poker chips, keeping costs dramatically down compared to foreign tooled and manufactured metal challenge coins. The initial coin order and the design work were covered by donation.

PDC Smith explained to the Camp the various design elements, which are included herein:

<u>Front Side</u>: This side comprises that the challenge coin is from Robert Finch Camp No. 14. It includes the fact that the Camp is the oldest active Camp in the Department of Michigan, including its establishment year of 1914. It also states the Camp's nickname of The Sharpshooters derived from the namesake of the Camp's regiment, and several Brothers' ancestors' regiment, the 1st Michigan Sharpshooters. The center design uses the sharpshooter from the 1st Michigan Sharpshooters Monument on the State Capitol grounds in Lansing.

The red, white, and blue motive are reminiscent of American professional sports leagues logos, while utilizing the patriotic color scheme.

<u>Back Side</u>: This side honors Sergeant Robert Finch, the namesake of the Camp. The outside rings are in sharpshooter green, and include text highlighting Sgt. Finch's service in the 1st Michigan Sharpshooters and his membership in Weatherwax GAR Post No. 75 in Grand Haven. The center insignia is the Ninth Corps badge as its specific design and color appears on the 1st Michigan Sharpshooters monument on the State Capitol grounds. Robert Finch was on the committee to fund and obtain the aforementioned monument.
